

### MUNICIPALITY OF ANCHORAGE PROCLAMATION OF EMERGENCY ORDER EO-15 "FOUR WEEK RESET"

ISSUED BY THE MAYOR OF THE MUNICIPALITY OF ANCHORAGE PURSUANT TO ANCHORAGE MUNICIPAL CODE SECTION 3.80.060H.

Over the past month the spread of COVID-19 has accelerated substantially in the Municipality. There is now widespread community transmission. Case counts are rising rapidly and the Municipality's capacity to trace and monitor every case has been exceeded. Monitoring for symptoms is not enough to control spread of the virus because people can infect others before they know they are sick. The number of people hospitalized with COVID-19 is increasing, and the latest model from the University of Alaska Anchorage indicates that local hospitals may run out of ICU bed capacity by mid-September if we do not act immediately to flatten the curve. This order is put forward to preserve the health and safety of our community.

I HEREBY ORDER THE FOLLOWING EMERGENCY RESPONSE TO PRESERVE LIFE IN AND ADJACENT TO THE MUNICIPALITY. THE FOLLOWING EMERGENCY REGULATIONS BEGIN AT 8:00 A.M. ON MONDAY, AUGUST 3, 2020 AND REMAIN IN EFFECT UNTIL 11:59 P.M. ON SUNDAY, AUGUST 30, 2020. THESE MANDATES SUPPLEMENT THE RESTRICTIONS IMPOSED BY EO-14. ALL PROVISIONS OF EO-14 AND ALL BUSINESS OPERATING CRITERIA FROM EO-10 REMAIN IN EFFECT UNLESS MODIFIED OR SUPPLEMENTED BELOW.

- 1. **Individuals.** Everyone in the Municipality of Anchorage (the "Municipality") shall limit outings and physical contact with those outside of their household and a small chosen group of other individuals. On the occasions when individuals leave home, they shall maintain physical distancing of at least six feet from any person outside their household/small group whenever possible. Individuals are required to wear a cloth face covering or mask in public, as detailed in Emergency Order 13. Individuals are also strongly encouraged to practice recommended hygiene, including regular hand washing.
- 2. At-Risk Individuals. It is strongly recommended, in accordance with guidance from the Centers for Disease Control and Prevention (CDC), that certain individuals within the Municipality continue to take even greater precaution. Anyone particularly at-risk of complications from COVID-19 should reduce exposure by staying at home, not physically going to work, minimizing in-person interactions with others, and not doing their own shopping if possible. particularly at risk of complications include those 65 years and older and individuals of any age with a serious underlying medical condition. Household members of those who are at elevated risk should implement these more stringent guidelines as well, to the extent possible.

- 3. Requirements for Individuals Likely To Be Contagious with COVID-19. Individuals likely to be contagious with COVID-19 are required to minimize contact with others as follows:
  - a. People who are exhibiting symptoms of COVID-19 (including the following symptoms when not attributable to other known causes: coughing, shortness of breath, fever, fatigue, chills, muscle pain, sore throat, headache, congestion or runny nose, diarrhea, or new loss of taste or smell) shall stay home except to seek medical care and testing.
  - b. Individuals who have traveled from outside Alaska are required to self-quarantine for fourteen days upon arrival/return to the State. Exceptions to the self-quarantine requirement exist only for those who obtain two negative COVID-19 testing results, as detailed in Emergency Order 11.
  - c. Household members of those who are possibly contagious should exercise physical distancing and enhanced hygiene within the home, and refrain from leaving the home to the extent possible.
  - d. Individuals who have been contacted by health authorities as a known contact of a positive case shall quarantine for the length of time directed by a public health professional.
  - e. Individuals who have tested positive for COVID-19 shall remain in isolation until cleared by a public health professional.
- 4. Gathering Limitations. All indoor gatherings with more than 15 people are prohibited—this includes business, cultural, political and religious gatherings. All outdoor gatherings involving consumption of food or drink must be limited to 25 people or fewer. Outdoor gatherings that do not involve food or drink are limited to 50 people. Masks are required to be worn at all gatherings, and six feet of physical distancing between household groups is required at all gatherings. Gatherings are defined as meetings or other events that bring together people from multiple households at the same time for a shared or group experience in a single room, space, or place such as an auditorium, stadium, arena, large conference room, meeting hall, or other indoor or outdoor space. The following exceptions apply to the gathering limits:
  - a. The gathering limitation does not limit shopping at farmer's markets or outdoor food-truck events where six-feet of physical distancing between customers is maintained, provided that on-site dining is prohibited and no tables or chairs are provided for dining.

- b. The gathering limitation does not limit drive-in events where groups remain within separate vehicles spaced at least six feet apart (or ten feet apart if singing by audience members is anticipated) so long as no food, drink, or other goods are passed between vehicles.
- c. The gathering limitation does not apply to day cares, day camps, or educational institutions for grades K-12. These entities must continue to follow the capacity limitations and other criteria in EO-10, Attachments E and F.
- 5. **Remote Work.** Employers shall require employees to work from home when their work can be accomplished remotely without significantly impeding business operations. Employers shall not knowingly permit symptomatic employees or others likely to be contagious with COVID-19 to enter the workplace or work outside the home.
- 6. Bars and Nightclubs Closed Except for Takeout or Delivery Service. All bars and nightclubs shall be closed except to allow takeout or delivery service. Bars are encouraged to offer takeout, curbside, and delivery service to the extent permitted by the laws governing alcohol sales.
- 7. **Restaurants and Breweries Closed to Indoor Dining.** All restaurants and breweries are closed to indoor dining. The outdoor areas of restaurants and breweries are limited to table service, with each table 10-feet apart or greater, as measured edge to edge. Restaurants and breweries are encouraged to offer takeout, curbside, and delivery service.
- 8. Bingo Halls and Theaters Closed. All bingo halls and theaters shall be closed.
- 9. Retail and Other Public-Facing Businesses. Retail stores and all other public-facing businesses are encouraged to prioritize telephone and online ordering; increase their offerings of curbside, entryway, and delivery services; and implement reserved hours of operation limited to high-risk populations.





## PROJECT PURPOSE AND NEED

- The purpose of the project is to improve non-motorized connectivity on Lois Drive and W. 32<sup>nd</sup> Avenue.
- The project is needed because existing non-motorized facilities are missing, discontinuous, or deteriorated, and the roadway and drainage systems are in poor condition.
- Lois Drive was listed as the Spenard Community Council's highest priority capital project for 2019.

### PROJECT GOALS

The project goals were developed to reconstruct the roadway to:

- Conform to AMC Title 21 and MOA Design Criteria Manual requirements
- Incorporate Complete Streets and Vision Zero objectives
- Address Stakeholder input wherever possible

Improvements evaluated to meet the project goals include:

- Roadway reconstruction and/or resurfacing
  - New curbs and storm drain improvements
- Sidewalks and/or pathways
- Street lighting
- Signage and landscaping
- Utility relocation as required due to roadway corridor improvements

## SIGNIFICANT DESIGN CHALLENGES

### Limited Right-of-Way

- Only 30-feet of ROW on eastern end of 32<sup>nd</sup> Avenue (at Minnesota Drive)
- Only 30-feet of ROW on Lois Drive to the south of 32<sup>nd</sup> Avenue (matches western edge of ROW to the north)
- Only 30-feet of ROW on 32nd Avenue to the west of Lois Drive (matches southern edge of ROW to the east)

### Jtilities

Electrical transmission and distribution poles in the middle of the W. 32<sup>nd</sup> Avenue ROW.

### Parking

Significant on-street parking usage at Aquarian Charter School during drop off and pickup

### ROADWAY ALTERNATIVES

- Four Alternatives were developed for each roadway
- Alternative 1 Fully compliant with MOA Title 21 and MOA Design Criteria Manual (7' wide snow storage buffers behind curb)
- Alternative 2 Narrower buffers to keep cross section within available Public Right-of-Way (ROW)
- Alternative 3 Remove buffers and shift roadway to minimize impacts to adjacent property, utilities, and other existing features.
- Alternative 4 Pathway Only
- Three Alternatives were developed for the intersection of Lois Drive and W. 32<sup>nd</sup> Avenue
- Shift north and east legs to line up with ROW on south and west legs.
  - 2. Shift south and west legs to line up with ROW on north and east legs
- Construct a roundabout northeast of the existing intersection.
- Roadway and intersection alternatives can be mixed for final preferred alternative.

You could ask ML&P or Chugach Electric to speed up the undergrounding of those lines on 32nd. It'll have to happen eventually.	Project team did reach out to them, and will put on list to follow up again and see if they have any interest in speeding that up to be constructed in conjuction with this project.
Matt hasn't mentioned a plan to relocate the fire hydrant in from of 2996 Lois to farther north. Can that be added to the list, or is it included somewhere already?	The alternatives for Lois indicate that those hydrants would be impacted and would be relocated as part of this project. Whether that means those being relocated just along its current path versus off to the side, we would have to determine and work with AWWU. It's going to be relocated.
Does the roundabout negate the need for moving the utilities?	Yes. That is one of the goals of the roundabout. One of the goals in addition to not impacting certain properties was not relocating the transmission pole. It is close but we would protect it with bollards, as we would on all alternatives that protect the transmission poles behind the curb. We would put protective bollards, so the roundabout does not require relocation of the transmission pole at this intersection.
How would the roundabout work with alternative 2?	That would have to be looked at further in design. We did not analyze those, I'm assuming you mean roundabout with roadway 2. It would work, we just didn't show it that way. Any of these intersections can be interchanged with any of the roadway alternatives. It would work, it would just look different.
Remind electric utilities that we've all been p aying undergrounding fees for years!	N/A
There are no ROW funds expected, right?	Correct. The next process is one we have a preferred alternative which would include expected costs for acquisition of right of way. Depending on those costs, right of way funding would either come separately if they are significant costs; for example, if they include relocation costs. Those are often funded separately ahead of the project. If they're minor costs, drainage easement, slope easement, etc. those are normally funded with the project. There are currently no design or ROW or construction funding.

## Virtual Open House #2 Question and Answer

So, to get the biggest bang for our buck, we would not move the utility pole and reduce the ROW needs.	Correct. That's why we added a variety of alternatives, we want to present something that meets the criteria that the MOA has worked hard to establish for the development of roadways within the area
It's my personal opinion that the roundabouts aren't necessary. Could you clarify why you think they are?	This would't have necessarily been a roadway in which our first intersection alternative was a roundabout. It seems like a pretty minor intersection; however, because of the constraints the roundabout actually gave us the best flexibility in moving the intersection. Which is truly what we are looking at with this one, moving the intersection. The associated traffic volumes did not say put a roundabout here. But the other factors of this project. The parcels, the property, the transmission poles, the fact that on the northeast corner we actually had, I wouldn't call it undeveloped in that it's being used by Aquarian Charter School but it's undeveloped in the sense that nobody lives there. Nobody's home is there. No transmission pole is there. So the roundabout really came about as an alternative that we could look at to reduce impacts to existing infrastructure and constraints that we had at this intersection.

## Good morning.

I'm writing to provide comments on the proposals for Lois Drive and 32d.

The single most important piece of these plans is filling in the missing stretch of sidewalk on Lois. There's a short sidewalk on the Northern Lights end, and a sidewalk along the Aquarian block on the 32d end. The missing strip is short. But the fact that there's no sidewalk on that stretch of road means that bicyclists and pedestrians are forced either into the street or into the parking lot. Neither of those are safe options for the bicyclists, or the pedestrians, or the vehicles driving in the street on in the parking lot. This is obviously especially a problem during the school drop off and pick up times. I've witnessed numerous near accidents between cars and bikes or walkers on the road during those times.

Making the walking and biking route safer has the added benefit of encouraging more families to walk or bike to school, which in turn has the added benefit of reducing traffic and parking congestion on 32d.

Alternative #4 for Lois Drive seems to address this problem without adding other costly changes. Those other proposed changes may well be good ideas, but their additional costs make them unattainable - or at best unattainable without years of additional delay. I'd much rather see the safety issues created by this gap in the sidewalk fixed ASAP. Is it possible to separate out that single issue from the other potential improvements?

Dear Lois Drive/32nd Avenue Project Team:

Thank you for the opportunity to provide comments on the Lois Dr/32nd Avenue project. For the record, I thought the public process provided by CRW and Huddle AK was top notch. I'm glad to review the alternatives provided. You all made it easy and enjoyable to be a stakeholder for this study. I mean it!

I sat down with Muni Traffic, PM&E and key Anchorage Assembly members a couple years ago in my role as Spenard Community Council president and talked about the need to move ahead on non-motorized safety improvements in this project area. Critical improvements to Lois Drive have been stymied for 25 years by enormous financial hurdles and right of way challenges. PM&E staff educated me on a couple key points, namely, that significant road bed issues exist in this project area. Those issues need to be addressed, along with utility improvements such as lighting, stormwater and emergency responder considerations. I don't think the answer is to build a larger level of service for this roadway. It should not be an arterial. But there are many pathways forward, even in a stark budget environment.

A couple neighbors and I wanted to just use our bare hands to build a path from Aquarian through the Condominiums right of way on the east side of Lois Drive (it should be Lois Lane!!) with shovels, wheelbarrows and chainsaws. We were tired of seeing wheelchairs and strollers rolling down the middle of Lois Drive in February because there is no sidewalk and it's the only North-South route for a half mile in either direction.

With the help of key Assembly members and Anchorage voters, we were able to crack open a bond package for a \$500,000 Design Study Report. Moving ahead, I think it's clear the Municipality of Anchorage is not swimming in money. We can't, in the near term, afford a big road bed project that includes a lot of right of way acquisition and road bed/utility improvements. But we should use this opportunity (and DSR funding) to plan for it.

The school bond issue approved by voters and campaigned for by these same Lois Drive stakeholders will provide a new roof for Aquarian Charter School. The \$6.5 million we got the hard way will pay for many other plant improvements on ASD property. It is proceeding next summer and it's clear we need to take advantage of this opportunity to make the best possible expenditures for Anchorage taxpayers by building complementary projects.

I support the Lois Drive Alternative 4 (pathway only) project as a Phase 1 implementation. I agree we need to consider how to meet all the needs identified by PM&E, Muni Traffic, ASD and the local stakeholders. I think the best way forward is to use design monies to create a phased plan which starts with a continuous pathway on the east side of Lois Drive. Phase II should be the Lois/West 32nd intersection (including the roundabout idea). I never would have thought of that. It's a good idea. Phase III should be 32nd Avenue on-street parking and pathway improvements. Phase IV needs to consider PM&E's important roadbed and utility upgrades on Lois Drive north from the 32nd Avenue roundabout.

Just one quibble. I had extensive conversations with Muni Traffic (and Mr. Myland in Traffic Calming) and the 2014 data clearly showed a need for Lois Drive traffic calming. Is there a way we can get traffic calming funding engaged here?

Hello,

I am a member of the community that travels on Lois Drive and W. 32nd Avenue most weekdays when school is in session. I have two children who attend Aquarian Charter School, and I live very nearby in Huntington Park neighborhood. For the full time that my children have attended the school, I have noted that both Lois Drive and W. 32nd Ave are unsafe for pedestrians, which are often children. The areas of concern that I have noted include:

- 1. W. 32nd in front of Aquarian: pedestrians do not have any place to walk, other than in the street. They walk on the side of the street in front of the school, which gets very crowded with cars waiting in line and cars going in and out of the parking lot. I have often thought that it is very dangerous for the students who walk across that section to and from their homes.
- 2. Lois Ave between Benson and W 32nd: pedestrians and cyclists can't easily use the sidewalk given the many cracks and bumps, so they walk along the side of the road. During school drop off and pick up, it is very hard for two cars to pass each other without putting the cyclists and pedestrians at risk.
- 3. The NE corner of Lois and W 32nd: On school mornings, children wait at that corner for a school bus. While the kids are usually good about staying back from the street, it is often dark and hard to see them. It is a risky place for the kids to stand, and there isn't a sidewalk area where they can safely wait in that spot.

Dear 42<sup>nd</sup> Avenue Project Team, Dear Lois & 32<sup>nd</sup> Project Team,

Thank you for the opportunity to provide comments regarding 42<sup>nd</sup> Avenue Upgrade project. I'm in full support of any upgrades and improvements that provide a more equitable access experience in our community. I think the 42<sup>nd</sup> avenue project is trying to do this. Foregrounding the needs of people who don't drive, will make our community

better for everyone. I understand that funds have only been appropriated to study a small section of neighborhood surrounding Aquarian Charter School. I would support a broader exploration of how to make the full length of Lois Drive safer for pedestrians and bikers. If we really want to support kids and families and equity, we would look at the roadways from the Woodland Park Boys and Girls Club to Aquarian Charter School and the surrounding neighborhood through the lens of equitable access.

My kids attend Aquarian Charter School and we live adjacent to the Boys and Girls Club at Woodland Park, yet we rarely walk or bike to school because it does not feel safe. I enjoy the privilege of being able to drive my kids to school, so the fact that walking/biking is unsafe does not dramatically impact our life; however, I imagine there are others in my neighborhood whose children experience the unsafe walking conditions as they travel to Aquarian or Boys and Girls Club playground/facility. All schools and recreation centers like the B & G club should have pedestrian/bike accessibility improvements for at least a mile radius around the facilities. This should be a given for any school and recreation center – not just schools who have organized parents who can advocate for improvements.

It can feel like taking your life in your own hands traveling on the road network in this section of Spenard as either a pedestrian or biker (actually in the entirety of our community except for the more historic and well-designed communities of Government Hill, Downtown, Fairview, and Mtn View.) The entire road network in this area of Spenard does not have sidewalks or drainage or even curbs. It's astonishing that a city in the 21<sup>st</sup> century would have neighborhoods with multiple parks, community centers, and schools, without clear walking and biking routes. It sort of seems like an ADA accessibility law suit waiting to happen.

Can we pass an ordinance that requires a walkability/ADA accessibility audit be done for every public school, recreation center, bus stop, library, and park to include a mile radius around the public facility and then use the findings to direct funding for improvements that promote transportation equity? This would help support the numerous plans that have been adopted by the MOA that say we need better walking and biking – Vison Zero, Climate Action Plan, Welcoming Anchorage Roadmap, AMATS Coordinated Human Services Transportation Plan, Non-Motorized Transportation Plan, AMATS Complete Streets Policy, 2040 Comprehensive Plan, West Anchorage District Plan, Spenard Road Corridor Plan. (Wow, maybe it's time to stop planning and implement some of the ideas in these plans.)

Again, I appreciate the opportunity to provide input for this project. I've cced the Assembly Members for District 3 as well as the Assembly Members who serve on the AMATS Policy Committee, and the Spenard Community Council.
